2. An Expert Team conducted onsite evaluation of the programs from 17th to 19th January, 2025. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to SJVPM's Rasiklal M Dhariwal Institute of Technology, Pawanagar, Chinchwad, Pune, Maharashtra-411033 as a whole.
